Release of Liability / Agreement Not to Sue

THIS DOCUMENT AFFECTS YOUR LEGAL RIGHTS, READ IT CAREFULLY

I, _____ (Hereinafter referred to as 'Participant') am aware that 'Volunteer Work' may include certain risks, including but not limited to the risk of accident, serious injury or death. I am voluntarily participating in this activity with full knowledge of the risks and dangers involved and hereby specifically agree to assume and accept full responsibility for any such risks and dangers involved.

FOR AND IN CONSIDERATION OF permission to participate in volunteer activities in connection with **GOD'S PANTRY** (Hereinafter referred to as 'GP');

- I hereby agree that I will not sue or otherwise make any claim against GP or any other sponsors, providers, affiliates, employees, agents or contractors for any loss, injury or damage resulting from my participation in volunteer activities at GP, including the negligence of any party.
- I hereby agree that GP or any other sponsors, providers, affiliates, employees, officers, members, agents or contractors shall not be legally responsible for any loss, injury or damages resulting from any cause, including the negligence of any party.
- I hereby agree that the use of the facilities will be according to the rules and instructions of GP and any other sponsors, providers, officers or affiliates.
- I hereby agree that any equipment or supplies that I may provide or which I may use, borrow or rent from GP or any other sponsors, providers or affiliates during this volunteer activity, I use at my own risk. I understand and agree that GP, any other sponsors, providers or affiliates shall not be liable for any loss, damage or injury resulting from the use or suitability of any such equipment or supplies. GP and any other sponsors or providers make no representations or warranties of any kind.
- To the fullest extent allowed by law, I hereby agree to RELEASE, INDEMNIFY and HOLD HARMLESS GP and any other sponsors, providers, affiliates, employees, officers, members, agents or contractors of and from all actions and claims for myself, my heirs, estate or personal representative(s) for any loss, injury, death or damages resulting from my participation in volunteer activities including the use of any equipment or supplies.
- The terms of this RELEASE shall also be binding as to any other persons including all family members, heirs, executors or administrators and including any minors which may accompany me. I understand this is a binding legal contract that supersedes any other agreements or representations and is intended to provide a comprehensive RELEASE of liability, but is not intended to assert any defenses which are prohibited by law. If any part of this RELEASE is deemed unenforceable, all other parts shall be given full force effect.
- It is further agreed that (if applicable), Participant or Contractor shall be responsible, at his or her sole cost and expense, for obtaining, securing or otherwise causing to be secured, any permits, licenses, grants or other documents as may be required by municipal or state law, regulation or local ordinance and hereby agree to abide by all such laws, regulations or local ordinances while on the premises of GP. Participant or Contractor shall not be considered an employee, agent, servant or representative of GP and Participant or Contractor shall indemnify, save and hold harmless GP, of and from any act or fine levied by municipal or state governmental entity due to actions, errors or omissions of Participant or Contractor.
- I hereby stipulate that I am legally competent to sign this RELEASE. If applicable, my parent or legal guardian has also read and signed this RELEASE.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. I HEREBY SIGN THE RELEASE AND INDEMNITY AGREEMENT OF MY OWN FREE WILL FOR THE CONSIDERATION AND PURPOSE EXPRESSED HEREIN.
